Kim Gerdes and Sylvain Kahane have been collaborating for 20 years and have published together more than 40 articles. They have been interested in different aspects of the syntax of languages. After working on formal modeling of word order in German and French, they started in 2008 to develop annotated corpora in dependency syntax for spoken French, focusing both on theoretical problems of dependency analysis and on questions more specifically raised by oral productions, notably concerning the limits of syntax.
