KEENE DOES NOT SHY AWAY FROM ADDRESSING THESE TENSIONS, PROVIDING A BALANCED VIEW OF PROGRESS AND SETBACKS.

THIS SYNTHESIS MAKES HER BOOK PARTICULARLY VALUABLE FOR UNDERSTANDING THE WAR AS A CATALYST FOR THE MODERN AMERICAN STATE AND IDENTITY. WHILE **DOUGHBOYS: THE GREAT WAR AND THE REMAKING OF AMERICA** EXCELS IN MANY AREAS, A FEW LIMITATIONS ARE WORTH NOTING. ON THE POSITIVE SIDE, THE BOOK'S DEPTH OF RESEARCH AND NARRATIVE CLARITY ARE COMMENDABLE. KEENE'S ABILITY TO WEAVE PERSONAL STORIES WITH BROADER HISTORICAL TRENDS OFFERS READERS A MULTIFACETED UNDERSTANDING OF THE ERA.

HOWEVER, SOME CRITICS MIGHT ARGUE THAT THE BOOK OCCASIONALLY UNDERREPRESENTS THE INTERNATIONAL CONTEXT IN WHICH AMERICAN SOLDIERS OPERATED. ALTHOUGH THE FOCUS ON THE U.S. IS INTENTIONAL AND JUSTIFIED, READERS SEEKING A BROADER STRATEGIC OR DIPLOMATIC ANALYSIS OF WORLD WAR I MIGHT FIND THIS ASPECT LESS EMPHASIZED.
