UNDERSTANDING POLITICAL THEOLOGY

THIS FOUNDATIONAL IDEA SPARKED WIDESPREAD SCHOLARLY DEBATE AND OPENED A SPACE FOR ANALYZING THE THEOLOGICAL ROOTS OF POLITICAL AUTHORITY AND LEGITIMACY.

SECULARIZATION AND ITS DISCONTENTS

MANY SCHOLARS ENGAGE WITH THE PROCESS OF SECULARIZATION, QUESTIONING WHETHER THE MODERN SEPARATION OF CHURCH AND STATE IS AS CLEAR-CUT AS TRADITIONALLY ASSUMED. THE JOURNAL OF POLITICAL THEOLOGY OFTEN PUBLISHES CRITICAL

REFLECTIONS ON SECULARISM, ARGUING THAT RELIGION CONTINUES TO SHAPE POLITICAL LIFE EVEN IN OSTENSIBLY SECULAR SOCIETIES.

THIS GLOBAL LENS IS CRITICAL FOR APPRECIATING THE VARIED WAYS POLITICAL THEOLOGY INFORMS CONTEMPORARY WORLD POLITICS.
