The simulated performance of the tests sections also was greatly affected by the subgrade conditions, e.g., density, soil moisture, and water table depth. In general, predictions for the full depth asphalt sections indicate that they will not fail due to cracking, but two of the three criteria for subgrade rutting indicate failure before the five or 10 year design life of the sections.

Conventional sections are predicted not to fail due to subgrade rutting; however, sections including the more frost susceptible bases in their design are predicted to fail due to asphalt cracking relatively early in their design life, and sections with nonfrost susceptible bases are predicted to fail towards the end of the design life.
