FOR GENERAL CONTRACTORS, THIS MEANS DEMONSTRATING PROFICIENCY IN CONSTRUCTION CODES, CONTRACT LAW, PROJECT MANAGEMENT, AND FINANCIAL MANAGEMENT, ALONGSIDE EXPERTISE IN SPECIFIC TRADES SUCH AS ELECTRICAL, PLUMBING, OR HVAC.

EXAM STRUCTURE AND FORMAT

THE EXAM GENERALLY CONSISTS OF MULTIPLE-CHOICE QUESTIONS, WITH THE NUMBER OF QUESTIONS VARYING DEPENDING ON THE LICENSE CLASSIFICATION. CANDIDATES MUST ACHIEVE A PASSING SCORE ON BOTH THE BUSINESS AND LAW PORTION AND THE TRADE EXAM TO QUALIFY FOR LICENSURE.

- ****TRADE SECTION:**** TESTS TECHNICAL KNOWLEDGE RELEVANT TO THE SPECIFIC TRADE OR GENERAL CONTRACTING SKILLS.
