HOW TO SET UP YOUR EQUITY ALARM CLOCK

- CHOOSE THE ALARM SOUND, WHICH COULD BE A BUZZER, RADIO, OR A PRESET TONE.
- ACTIVATE THE ALARM BY TOGGING THE ALARM SWITCH OR PRESSING THE “ON/OFF” BUTTON.
- THE MANUAL WILL ALSO EXPLAIN HOW TO SET RECURRING ALARMS FOR WEEKDAYS OR WEEKENDS, A HANDY FEATURE TO AVOID RESETTING DAILY.

USING THE SNOOZE AND SLEEP FUNCTIONS

- THE SLEEP TIMER LETS YOU FALL ASLEEP TO MUSIC OR RADIO, AUTOMATICALLY TURNING OFF AFTER A SET TIME. CHECK THE MANUAL FOR INSTRUCTIONS ON ACTIVATING THIS FEATURE.

TROUBLESHOOTING COMMON ISSUES WITH YOUR EQUITY ALARM CLOCK

ALARM NOT SOUNDING

- CHECK VOLUME SETTINGS; THE VOLUME MIGHT BE TOO LOW OR MUTED.
- VERIFY THAT THE CORRECT ALARM MODE (RADIO, BUZZER, OR TONE) IS SELECTED.
- MAKE SURE THE CLOCK’S TIME IS SET CORRECTLY, AS AN INCORRECT TIME WILL PREVENT ALARMS FROM TRIGGERING.

DISPLAY PROBLEMS

IF THE SCREEN IS DIM, FLICKERING, OR BLANK:

- ADJUST THE BRIGHTNESS CONTROL KNOB OR BUTTON.
- CONFIRM THAT THE POWER CORD IS SECURELY CONNECTED.
- REPLACE BACKUP BATTERIES IF THE DISPLAY RESETS OR LOSES TIME AFTER POWER OUTAGES.

RADIO RECEPTION ISSUES

SOMETIMES THE BUILT-IN RADIO MAY HAVE POOR RECEPTION:

- TRY ADJUSTING THE ANTENNA, IF AVAILABLE.
- MOVE THE CLOCK CLOSER TO A WINDOW OR AWAY FROM ELECTRONIC DEVICES THAT MAY CAUSE INTERFERENCE.
- ENSURE YOU HAVE SELECTED THE CORRECT BAND (AM OR FM).
