ALONG WITH THE FPGEE, CANDIDATES TYPICALLY MUST COMPLETE THE FOREIGN PHARMACY GRADUATE EXAMINATION COMMITTEE (FPGEC) CERTIFICATION PROCESS.

KEY FPGEE EXAM DATES 2023

THE FPGEE IS OFFERED MULTIPLE TIMES THROUGHOUT THE YEAR, BUT THE EXACT TESTING WINDOWS AND REGISTRATION DEADLINES CAN VARY. FOR 2023, CANDIDATES SHOULD BE AWARE OF THE FOLLOWING CRITICAL TIMELINES:

TESTING WINDOWS

UNLIKE FIXED TEST DATES, THE FPGEE IS ADMINISTERED DURING SPECIFIC TESTING WINDOWS. IN 2023, THE NABP OFFERS THE EXAM DURING THE FOLLOWING PERIODS:

- SPRING TESTING WINDOW: LATE MARCH TO EARLY APRIL
- SUMMER TESTING WINDOW: LATE JUNE TO EARLY JULY
- FALL TESTING WINDOW: MID-OCTOBER TO EARLY NOVEMBER

THESE WINDOWS PROVIDE CANDIDATES WITH THE FLEXIBILITY TO SCHEDULE THEIR EXAM APPOINTMENTS AT PEARSON VUE TESTING CENTERS ACROSS THE COUNTRY AND INTERNATIONALLY.

REGISTRATION DEADLINES

REGISTRATION FOR THE FPGEE MUST BE COMPLETED WELL BEFORE THE TESTING WINDOWS CLOSE. TYPICALLY, NABP OPENS REGISTRATION APPROXIMATELY 60-90 DAYS PRIOR TO EACH TESTING WINDOW. FOR 2023, IT'S RECOMMENDED TO:

- REGISTER FOR THE SPRING SESSION BY LATE JANUARY TO EARLY FEBRUARY

- REGISTER FOR THE SUMMER SESSION BY LATE APRIL TO EARLY MAY
- REGISTER FOR THE FALL SESSION BY LATE JULY TO EARLY AUGUST

EARLY REGISTRATION IS ADVISED BECAUSE SEATS AT TESTING CENTERS CAN FILL UP QUICKLY, ESPECIALLY IN HIGH-DEMAND LOCATIONS.

SCHEDULING YOUR TEST APPOINTMENT

AFTER RECEIVING APPROVAL TO TAKE THE FPGEE FROM NABP, CANDIDATES CAN SCHEDULE THEIR EXAM APPOINTMENT WITHIN THE TESTING WINDOW. IT'S SMART TO SCHEDULE EARLY IN THE WINDOW TO ALLOW TIME FOR RETAKES IF NECESSARY AND TO AVOID LAST-MINUTE STRESS.

HOW TO REGISTER FOR THE FPGEE IN 2023

REGISTRATION FOR THE FPGEE INVOLVES A FEW IMPORTANT STEPS, AND UNDERSTANDING THE TIMELINE CAN MAKE THE PROCESS SMOOTHER.

STEP 1: OBTAIN FPGEC CERTIFICATION ELIGIBILITY

BEFORE REGISTERING FOR THE FPGEE, CANDIDATES MUST APPLY FOR AND OBTAIN ELIGIBILITY THROUGH THE FPGEC CERTIFICATION PROCESS. THIS INCLUDES SUBMITTING YOUR PHARMACY EDUCATION CREDENTIALS FOR VERIFICATION THROUGH THE PHARMACY CURRICULUM VERIFICATION SERVICE (PCVS) AND MEETING ENGLISH LANGUAGE PROFICIENCY REQUIREMENTS.

STEP 2: REGISTER ON THE NABP WEBSITE

ONCE YOUR ELIGIBILITY IS CONFIRMED, YOU CAN REGISTER FOR THE FPGEE ON THE NABP WEBSITE. DURING REGISTRATION, YOU'LL SELECT YOUR PREFERRED TESTING WINDOW AND EXAM LOCATION.

STEP 3: PAY THE EXAM FEE

THE FPGEE EXAM FEE IS APPROXIMATELY \$1,300 (SUBJECT TO CHANGE). PAYMENT MUST BE MADE DURING REGISTRATION TO SECURE YOUR SPOT.

STEP 4: SCHEDULE YOUR TEST APPOINTMENT

AFTER PAYMENT AND REGISTRATION, YOU'LL RECEIVE A SCHEDULING PERMIT TO BOOK YOUR EXAM DATE WITH PEARSON VUE.

TIPS FOR PLANNING AROUND FPGEE EXAM DATES 2023

KNOWING THE EXAM DATES IS JUST THE START. HERE ARE SOME PRACTICAL TIPS TO HELP YOU MAKE THE MOST OF YOUR PREPARATION AND SCHEDULING:

Candidates interested in taking the FPgEE in 2023 should note the following exam windows announced by NABP:

- **MARCH 1-15, 2023:** EARLY SPRING SESSION
- **JUNE 1-15, 2023:** SUMMER SESSION
- **SEPTEMBER 1-15, 2023:** FALL SESSION
- **DECEMBER 1-15, 2023:** WINTER SESSION

These windows allow candidates to select the most convenient date within the two-week period, subject to availability at their chosen Pearson VUE testing center.

Registration Deadlines and Eligibility

To secure a spot for the FPgEE within these dates, candidates must pay close attention to registration deadlines, which typically close approximately six to eight weeks before the exam window begins. For example, to sit for the MARCH 2023 exam, applicants needed to submit their application and payment by MID-JANUARY 2023.

THE NABP REQUIRES THAT CANDIDATES FIRST BE CERTIFIED BY THE FOREIGN PHARMACY GRADUATE EXAMINATION COMMITTEE (FPGEC), WHICH INVOLVES CREDENTIAL EVALUATION BY THE EDUCATIONAL CREDENTIAL EVALUATORS (ECE) OR ANOTHER APPROVED AGENCY. ONLY AFTER THIS CERTIFICATION PROCESS CAN THE CANDIDATE REGISTER FOR THE FPGEE.

IMPACT OF EXAM SCHEDULING ON CANDIDATE PREPARATION

SINCE THE FPGEE COVERS A BROAD RANGE OF TOPICS INCLUDING PHARMACOLOGY, PHARMACEUTICAL CALCULATIONS, PHARMACY LAW, AND CLINICAL SCIENCES, TIMING THE EXAM DATE TO ALIGN WITH READINESS CAN IMPROVE PERFORMANCE OUTCOMES.

COMPARISON WITH PREVIOUS YEARS' EXAM DATES

HISTORICALLY, THE NABP HAS MAINTAINED A CONSISTENT PATTERN OF OFFERING THE FPGEE FOUR TIMES ANNUALLY. COMPARING 2023 WITH PRIOR YEARS REVEALS A SIMILAR DISTRIBUTION OF EXAM WINDOWS, WITH MINOR ADJUSTMENTS IN EXACT DATES TO ACCOMMODATE WEEKENDS AND HOLIDAYS.

IN 2022, FOR INSTANCE, THE EXAM WINDOWS OCCURRED IN MARCH, JUNE, SEPTEMBER, AND DECEMBER, MIRRORING THE 2023 SCHEDULE. THIS CONSISTENCY BENEFITS CANDIDATES BY ALLOWING THEM TO PLAN WELL IN ADVANCE AND ANTICIPATE REGISTRATION PERIODS.

WHILE THE FPGEE FOCUSES ON EQUIVALENCY FOR FOREIGN GRADUATES, U.S.-TRAINED PHARMACY STUDENTS OFTEN TAKE THE PCOA AS PART OF THEIR EDUCATIONAL ASSESSMENT. UNDERSTANDING HOW THE FPGEE ALIGNS WITH DOMESTIC PHARMACY EDUCATION STANDARDS CAN AID CANDIDATES IN TAILORING THEIR PREPARATION.

STRATEGIC TIPS FOR MANAGING FPGEE EXAM DATES 2023

NAVIGATING THE FPGEE EXAM TIMELINE REQUIRES STRATEGIC PLANNING. CANDIDATES SHOULD CONSIDER THE FOLLOWING:

INTERNATIONAL PHARMACY GRADUATES SHOULD MONITOR OFFICIAL NABP ANNOUNCEMENTS CLOSELY FOR ANY UPDATES ON EXAM DATES OR PROCEDURAL CHANGES BEYOND 2023. STAYING INFORMED ENSURES SMOOTH PROGRESSION THROUGH THE LICENSURE PROCESS.
