PERCENTAGE RECEIVED = $(120 / 150) \times 100 = 80\%$.

THIS PROBLEM HELPS ASSESS COMPLIANCE OR SHORTFALL IN PAYMENTS.

EXAMPLE 3: SOLVING FOR UNKNOWN TAX RATES

A FARMER PAYS \$45 IN TAXES ON A SHIPMENT WORTH \$600. WHAT IS THE TAX RATE?

SOLUTION:

TAX RATE = $(\text{TAX PAID} / \text{SHIPMENT VALUE}) \times 100 = (45 / 600) \times 100 = 7.5\%$.

SUCH PROBLEMS ARE COMMON IN SCENARIOS WHERE TAX RATES VARY BY REGION OR PRODUCT TYPE.

TIPS FOR MASTERING TAX COLLECTOR MATH PROBLEMS
