UNDERSTANDING THESE DYNAMICS THROUGH THE LENS OF CONSTITUTIONAL LAW AND POLITICS O'BRIEN EQUIPS SCHOLARS AND PRACTITIONERS WITH TOOLS TO ANALYZE AND ANTICIPATE SHIFTS IN CONSTITUTIONAL GOVERNANCE.
