THIS HOLISTIC APPROACH ENSURES MBA GRADUATES ARE WELL-ROUNDED LEADERS WHO APPRECIATE THE FINANCIAL UNDERPINNINGS OF BUSINESS DECISIONS.

CORE CONCEPTS OF FINANCIAL ACCOUNTING FOR MBAs

UNDERSTANDING FINANCIAL STATEMENTS

EVERY MBA STUDENT SHOULD BE FLUENT IN READING AND ANALYZING THE THREE PRIMARY FINANCIAL STATEMENTS:

- **BALANCE SHEET:** PROVIDES A SNAPSHOT OF A COMPANY'S FINANCIAL POSITION AT A SPECIFIC POINT IN TIME, DETAILING ASSETS, LIABILITIES, AND SHAREHOLDERS' EQUITY.
- **INCOME STATEMENT:** SHOWS COMPANY PROFITABILITY OVER A PERIOD, OUTLINING REVENUES, EXPENSES, AND NET INCOME.
- **CASH FLOW STATEMENT:** TRACKS THE INFLOW AND OUTFLOW OF CASH, HIGHLIGHTING OPERATIONAL EFFICIENCY AND LIQUIDITY.

EACH STATEMENT OFFERS UNIQUE INSIGHTS, AND TOGETHER, THEY PAINT A COMPREHENSIVE PICTURE OF AN ORGANIZATION'S FINANCIAL HEALTH.

ACCRUAL VS. CASH ACCOUNTING

ONE COMMON AREA OF CONFUSION FOR MANY IS THE DISTINCTION BETWEEN ACCRUAL AND CASH ACCOUNTING METHODS. CAMBRIDGE MBA COURSES EMPHASIZE THE ACCRUAL BASIS, WHERE REVENUES AND EXPENSES ARE RECOGNIZED WHEN EARNED OR INCURRED, REGARDLESS OF CASH MOVEMENT. THIS APPROACH PROVIDES A MORE ACCURATE REFLECTION OF A COMPANY'S ECONOMIC ACTIVITIES AND IS CRUCIAL FOR EFFECTIVE FINANCIAL ANALYSIS.

KEY FINANCIAL RATIOS AND THEIR INTERPRETATION
