UNDERSTANDING THE CDA EXAM AND ITS IMPORTANCE

THE CDA CREDENTIAL IS AWARDED BY THE COUNCIL FOR PROFESSIONAL RECOGNITION AND IS DESIGNED TO VALIDATE THE KNOWLEDGE AND SKILLS OF EARLY CHILDHOOD EDUCATORS. THE EXAM ITSELF EVALUATES CANDIDATES ON A VARIETY OF DOMAINS INCLUDING PLANNING A SAFE AND HEALTHY LEARNING ENVIRONMENT, ADVANCING CHILDREN'S PHYSICAL AND INTELLECTUAL DEVELOPMENT, AND BUILDING POSITIVE RELATIONSHIPS WITH FAMILIES.

BECAUSE THE EXAM IS COMPREHENSIVE AND COVERS A BROAD RANGE OF TOPICS, IT CAN BE CHALLENGING. MANY CANDIDATES WONDER ABOUT THE POSSIBILITY OF RETAKING THE EXAM IF THEY DON'T PASS OR IF THEY WANT TO IMPROVE THEIR SCORE.

CAN YOU RETAKE THE CDA EXAM? HERE'S WHAT YOU NEED TO KNOW

YES, YOU CAN RETAKE THE CDA EXAM IF YOU DO NOT PASS ON YOUR FIRST TRY. THE COUNCIL FOR PROFESSIONAL RECOGNITION ALLOWS CANDIDATES TO RETAKE THE EXAM, BUT THERE ARE SPECIFIC GUIDELINES AND WAITING PERIODS TO CONSIDER.

RETAKE POLICIES AND WAITING PERIODS

AFTER COMPLETING THE CDA EXAM, IF YOU DON'T MEET THE REQUIRED PASSING SCORE, YOU WILL BE INFORMED OF YOUR RESULTS. CANDIDATES ARE TYPICALLY ALLOWED TO RETAKE THE EXAM; HOWEVER, YOU MUST WAIT A CERTAIN AMOUNT OF TIME BEFORE ATTEMPTING THE EXAM AGAIN. THIS WAITING PERIOD IS USUALLY 60 DAYS FROM THE DATE OF YOUR PREVIOUS EXAM.

THIS WAITING PERIOD IS DESIGNED TO GIVE CANDIDATES TIME TO REVIEW THEIR EXAM RESULTS, IDENTIFY AREAS OF WEAKNESS, AND PREPARE MORE THOROUGHLY BEFORE RETAKING THE TEST. IT'S IMPORTANT TO USE THIS TIME WISELY RATHER THAN RUSHING INTO A RETAKE WITHOUT ADEQUATE PREPARATION.

NUMBER OF ALLOWED RETAKES

WHILE THE COUNCIL DOES NOT EXPLICITLY LIMIT THE NUMBER OF TIMES YOU CAN RETAKE THE CDA EXAM, IT'S ESSENTIAL TO KEEP IN MIND THAT EACH EXAM ATTEMPT REQUIRES A NEW APPLICATION AND FEE. THEREFORE, MULTIPLE RETAKES CAN BECOME COSTLY AND TIME-CONSUMING.

TO AVOID EXCESSIVE RETAKES, FOCUS ON BUILDING A SOLID STUDY PLAN AFTER YOUR FIRST ATTEMPT, TARGETING THE SPECIFIC AREAS WHERE YOU STRUGGLED.

PREPARING FOR A CDA EXAM RETAKE: TIPS AND STRATEGIES

RETAKING AN EXAM CAN FEEL DAUNTING, BUT WITH THE RIGHT APPROACH, IT'S AN OPPORTUNITY TO IMPROVE AND SUCCEED. HERE ARE SOME PRACTICAL STRATEGIES TO HELP YOU PREPARE FOR YOUR CDA EXAM RETAKE.

REVIEW YOUR EXAM FEEDBACK

IF YOU DIDN'T PASS ON YOUR FIRST TRY, MAKE SURE TO CAREFULLY REVIEW ANY FEEDBACK OR SCORE REPORTS PROVIDED. THESE CAN HIGHLIGHT WHICH COMPETENCY AREAS NEED MORE ATTENTION, WHETHER IT'S CHILD DEVELOPMENT THEORY, SAFETY PROTOCOLS, OR FAMILY ENGAGEMENT TECHNIQUES.

CREATE A TARGETED STUDY PLAN

ONCE YOU IDENTIFY YOUR WEAK SPOTS, DEVELOP A STUDY PLAN THAT FOCUSES ON THOSE TOPICS. USE CDA PREPARATION BOOKS, ONLINE COURSES, AND PRACTICE EXAMS TO REINFORCE YOUR KNOWLEDGE. CONSIDER JOINING A STUDY GROUP OR SEEKING SUPPORT FROM FELLOW EARLY CHILDHOOD EDUCATORS.

UTILIZE CDA EXAM RESOURCES

THERE ARE NUMEROUS RESOURCES AVAILABLE TO HELP CANDIDATES PREPARE FOR THE CDA EXAM RETAKE, INCLUDING:

- THE OFFICIAL CDA COMPETENCY STANDARDS AND RESOURCE MANUAL
- ONLINE PRACTICE TESTS AND QUIZZES
- WORKSHOPS AND WEBINARS OFFERED BY THE COUNCIL OR LOCAL TRAINING PROVIDERS
- FLASHCARDS AND EDUCATIONAL APPS TAILORED TO CDA CONTENT

LEVERAGING THESE RESOURCES CAN BOOST YOUR CONFIDENCE AND ENSURE YOU'RE BETTER PREPARED FOR THE NEXT EXAM ATTEMPT.

PRACTICE SELF-CARE AND MANAGE TEST ANXIETY

TEST ANXIETY CAN IMPACT PERFORMANCE, ESPECIALLY WHEN RETAKING AN EXAM. PRACTICE RELAXATION TECHNIQUES SUCH AS DEEP BREATHING, MEDITATION, OR VISUALIZATION TO CALM YOUR MIND BEFORE AND DURING THE TEST. REMEMBER, THE CDA EXAM IS DESIGNED TO ASSESS YOUR KNOWLEDGE AND SKILLS, NOT TO INTIMIDATE YOU.

ADDITIONAL FACTORS TO CONSIDER WHEN RETAKING THE CDA EXAM

RETAKING THE CDA EXAM INVOLVES MORE THAN JUST STUDYING. HERE ARE SOME OTHER CONSIDERATIONS TO KEEP IN MIND.

APPLICATION AND FEES

EACH TIME YOU RETAKE THE CDA EXAM, YOU WILL NEED TO SUBMIT A NEW APPLICATION AND PAY THE EXAM FEE AGAIN. MAKE SURE YOU BUDGET FOR THESE COSTS AND CONFIRM THE CURRENT FEE STRUCTURE ON THE COUNCIL FOR PROFESSIONAL RECOGNITION'S OFFICIAL WEBSITE, AS FEES MAY CHANGE.

MAINTAINING ELIGIBILITY

BEFORE RETAKING THE EXAM, DOUBLE-CHECK THAT YOU STILL MEET THE ELIGIBILITY REQUIREMENTS FOR THE CDA CREDENTIAL. THIS TYPICALLY INCLUDES HAVING COMPLETED THE REQUIRED NUMBER OF TRAINING HOURS AND HAVING EXPERIENCE WORKING WITH YOUNG CHILDREN.

CHOOSING THE RIGHT EXAM SETTING

THE CDA EXAM CAN BE TAKEN IN DIFFERENT FORMATS, INCLUDING ONLINE REMOTE PROCTORED EXAMS OR IN-PERSON TESTING CENTERS. CONSIDER WHICH SETTING SUITS YOU BEST FOR YOUR RETAKE TO MAXIMIZE COMFORT AND MINIMIZE DISTRACTIONS.

WHAT HAPPENS AFTER YOU PASS THE CDA EXAM?

ONCE YOU SUCCESSFULLY PASS THE CDA EXAM, YOU CAN PROCEED WITH THE REMAINING STEPS TO EARN YOUR CREDENTIAL, WHICH MAY INCLUDE SUBMITTING A PROFESSIONAL PORTFOLIO AND COMPLETING AN OBSERVATION. PASSING THE EXAM IS A SIGNIFICANT MILESTONE, AND RETAKING IT IF NEEDED IS JUST PART OF THE JOURNEY TOWARD BECOMING A CERTIFIED EARLY CHILDHOOD PROFESSIONAL.

BY UNDERSTANDING THAT YES, YOU CAN RETAKE THE CDA EXAM AND PREPARING EFFECTIVELY, YOU SET YOURSELF UP FOR SUCCESS. REMEMBER, MANY CANDIDATES DON'T PASS ON THEIR FIRST TRY, AND THE OPPORTUNITY TO RETAKE THE EXAM ALLOWS YOU TO DEMONSTRATE YOUR COMMITMENT AND KNOWLEDGE IN EARLY CHILDHOOD EDUCATION.

FREQUENTLY ASKED QUESTIONS

CAN YOU RETAKE THE CDA EXAM IF YOU FAIL IT?

YES, YOU CAN RETAKE THE CDA EXAM IF YOU DO NOT PASS IT ON YOUR FIRST ATTEMPT. THERE ARE NO LIMITS TO THE NUMBER OF TIMES YOU CAN RETAKE THE EXAM, BUT YOU MUST PAY THE EXAM FEE EACH TIME.

IS THERE A WAITING PERIOD BEFORE RETAKING THE CDA EXAM?

CURRENTLY, THERE IS NO MANDATORY WAITING PERIOD TO RETAKE THE CDA EXAM AFTER FAILING. YOU CAN SCHEDULE YOUR RETAKE AS SOON AS YOU FEEL PREPARED AND THE TESTING CENTER HAS AVAILABILITY.

DO YOU HAVE TO RETAKE THE ENTIRE CDA EXAM OR ONLY THE SECTIONS YOU FAILED?

WHEN RETAKING THE CDA EXAM, YOU MUST RETAKE THE ENTIRE EXAM. THE CDA CREDENTIALING PROCESS REQUIRES A COMPLETE ASSESSMENT EACH TIME.

ARE THERE ANY ADDITIONAL REQUIREMENTS BEFORE RETAKING THE CDA EXAM?

THERE ARE NO ADDITIONAL REQUIREMENTS SUCH AS EXTRA COURSEWORK BEFORE RETAKING THE CDA EXAM, BUT IT IS RECOMMENDED TO REVIEW THE AREAS WHERE YOU STRUGGLED TO IMPROVE YOUR CHANCES OF PASSING.

HOW CAN I PREPARE BETTER FOR THE CDA EXAM RETAKE?

CAN YOU RETAKE THE CDA EXAM IS A QUESTION FREQUENTLY POSED BY EARLY CHILDHOOD EDUCATORS AND PROFESSIONALS SEEKING TO EARN OR RENEW THEIR CHILD DEVELOPMENT ASSOCIATE (CDA) CREDENTIAL. THE CDA CREDENTIAL, ADMINISTERED BY THE COUNCIL FOR PROFESSIONAL RECOGNITION, IS A NATIONALLY RECOGNIZED CERTIFICATION THAT VALIDATES AN INDIVIDUAL'S SKILLS AND COMPETENCIES IN EARLY CHILDHOOD EDUCATION. GIVEN THE EXAM'S IMPORTANCE AND THE RIGOROUS STANDARDS IT UPHOLDS, MANY CANDIDATES WONDER ABOUT THE RETAKE POLICIES, ELIGIBILITY CRITERIA, AND STRATEGIC CONSIDERATIONS INVOLVED IF THEY NEED TO ATTEMPT THE EXAM MORE THAN ONCE.

THIS ARTICLE PROVIDES AN IN-DEPTH ANALYSIS OF THE RETAKE POSSIBILITIES FOR THE CDA EXAM, EXPLORING THE OFFICIAL GUIDELINES, PRACTICAL IMPLICATIONS, AND BEST PRACTICES FOR CANDIDATES AIMING TO MAXIMIZE THEIR CHANCES OF SUCCESS.

OVERVIEW OF THE CDA CREDENTIAL AND EXAM STRUCTURE

BEFORE DELVING INTO WHETHER YOU CAN RETAKE THE CDA EXAM, IT IS IMPORTANT TO UNDERSTAND WHAT THE CREDENTIAL ENTAILS. THE CDA CREDENTIAL ASSESSES KNOWLEDGE AND SKILLS RELATED TO CHILD DEVELOPMENT, SAFETY, HEALTH, LEARNING ENVIRONMENT, AND PROFESSIONALISM. THE PROCESS INVOLVES MULTIPLE COMPONENTS, INCLUDING A WRITTEN EXAM, A PROFESSIONAL PORTFOLIO, AND A VERIFICATION VISIT BY A CDA PROFESSIONAL DEVELOPMENT SPECIALIST.

THE CDA EXAM ITSELF IS A COMPUTER-BASED TEST CONSISTING OF MULTIPLE-CHOICE QUESTIONS DESIGNED TO EVALUATE A CANDIDATE'S UNDERSTANDING OF EARLY CHILDHOOD EDUCATION PRINCIPLES AND PRACTICES. PASSING THIS EXAM IS A CRITICAL STEP TOWARD EARNING THE CREDENTIAL.

CAN YOU RETAKE THE CDA EXAM? OFFICIAL POLICIES AND GUIDELINES

THE SHORT ANSWER TO WHETHER YOU CAN RETAKE THE CDA EXAM IS YES. THE COUNCIL FOR PROFESSIONAL RECOGNITION ALLOWS CANDIDATES TO RETAKE THE EXAM IF THEY DO NOT PASS ON THEIR FIRST ATTEMPT. HOWEVER, THERE ARE SPECIFIC POLICIES AND TIMELINES THAT CANDIDATES MUST BE AWARE OF:

RETAKE ELIGIBILITY AND WAITING PERIOD

CANDIDATES WHO FAIL THE CDA EXAM ARE TYPICALLY REQUIRED TO WAIT A MINIMUM PERIOD BEFORE RETAKING IT. THIS WAITING PERIOD IS GENERALLY 30 DAYS, A POLICY DESIGNED TO ENCOURAGE CANDIDATES TO SPEND ADEQUATE TIME REVIEWING AND PREPARING BEFORE ATTEMPTING THE EXAM AGAIN. THIS WAITING TIME HELPS MAINTAIN THE EXAM'S INTEGRITY AND ENSURES THAT CANDIDATES DO NOT REPEATEDLY TAKE THE TEST WITHOUT ADDITIONAL PREPARATION.

NUMBER OF ATTEMPTS ALLOWED

WHILE THE COUNCIL DOES NOT EXPLICITLY LIMIT THE TOTAL NUMBER OF TIMES A CANDIDATE CAN RETAKE THE CDA EXAM, REPEATED FAILURES CAN DELAY CREDENTIALING AND INCUR ADDITIONAL COSTS. CANDIDATES SHOULD AIM TO PREPARE THOROUGHLY BEFORE EACH ATTEMPT. IT IS ADVISABLE TO USE THE FEEDBACK FROM PREVIOUS TEST ATTEMPTS, IF AVAILABLE, TO FOCUS ON WEAKER AREAS.

FEES ASSOCIATED WITH RETAKING THE EXAM

RETKING THE CDA EXAM INVOLVES PAYING THE EXAM FEE AGAIN. THE COST FOR THE CDA APPLICATION AND EXAM CAN VARY, BUT AS OF RECENT DATA, IT TYPICALLY RANGES AROUND \$425 FOR THE FULL APPLICATION AND ASSESSMENT PROCESS. THE RETAKE FEE COVERS ADMINISTRATIVE COSTS AND ACCESS TO THE EXAM PLATFORM. CANDIDATES SHOULD BUDGET FOR THESE EXPENSES IF MULTIPLE ATTEMPTS ARE ANTICIPATED.

STRATEGIES FOR RETAKING THE CDA EXAM SUCCESSFULLY

UNDERSTANDING THAT YOU CAN RETAKE THE CDA EXAM IS REASSURING, BUT SUCCESS DEPENDS ON HOW YOU APPROACH SUBSEQUENT ATTEMPTS. THE FOLLOWING STRATEGIES CAN HELP IMPROVE PERFORMANCE:

1. ANALYZE YOUR PREVIOUS EXAM PERFORMANCE

IF THE EXAM FEEDBACK HIGHLIGHTS SPECIFIC AREAS OF WEAKNESS, FOCUS YOUR STUDY EFFORTS THERE. COMMON CHALLENGING TOPICS INCLUDE CHILD DEVELOPMENT THEORIES, HEALTH AND SAFETY STANDARDS, AND FAMILY ENGAGEMENT STRATEGIES.

2. ENHANCE PREPARATION WITH STUDY MATERIALS

UTILIZE OFFICIAL CDA STUDY GUIDES, PRACTICE TESTS, AND TRAINING WORKSHOPS. MANY CANDIDATES BENEFIT FROM ENROLLING IN CDA PREPARATION COURSES TO REINFORCE THEIR KNOWLEDGE AND GAIN CONFIDENCE.

3. LEVERAGE PEER AND MENTOR SUPPORT

CONNECTING WITH EXPERIENCED EDUCATORS OR MENTORS WHO HOLD THE CDA CREDENTIAL CAN PROVIDE INSIGHTS INTO EXAM CONTENT AND PROFESSIONAL EXPECTATIONS.

4. MANAGE TEST ANXIETY

TEST-TAKING STRATEGIES SUCH AS TIME MANAGEMENT, RELAXATION TECHNIQUES, AND SIMULATED PRACTICE EXAMS CAN REDUCE ANXIETY AND IMPROVE FOCUS DURING THE REAL EXAM.

COMPARING THE CDA EXAM RETAKE POLICY WITH OTHER EARLY CHILDHOOD CERTIFICATIONS

WHEN CONSIDERING THE CDA EXAM RETAKE POLICY, IT IS HELPFUL TO COMPARE IT WITH SIMILAR CERTIFICATIONS IN EARLY CHILDHOOD EDUCATION. FOR EXAMPLE:

- **CERTIFIED CHILDCARE PROFESSIONAL (CCP):** SOME STATES REQUIRE CANDIDATES TO WAIT 14 TO 30 DAYS BEFORE RETAKING CCP EXAMS, SIMILAR TO THE CDA.
- **NATIONAL CHILDCARE ASSOCIATION (NCA) CERTIFICATION:** OFTEN PERMITS MULTIPLE RETAKES BUT MAY IMPOSE A CAP ON THE NUMBER OF ATTEMPTS WITHIN A CERTAIN TIMEFRAME.

THE CDA'S RETAKE POLICY IS GENERALLY CONSISTENT WITH INDUSTRY STANDARDS, BALANCING ACCESSIBILITY WITH MAINTAINING HIGH PROFESSIONAL STANDARDS.

IMPLICATIONS OF RETAKING THE CDA EXAM ON CAREER PROGRESSION

RETKING THE CDA EXAM CAN HAVE BOTH ADVANTAGES AND DISADVANTAGES IN TERMS OF CAREER DEVELOPMENT.

PROS

- **OPPORTUNITY FOR MASTERY:** RETAKES ALLOW CANDIDATES TO REFINE THEIR KNOWLEDGE AND BETTER DEMONSTRATE THEIR COMPETENCIES.
- **CREDENTIAL ATTAINMENT:** SUCCESSFULLY PASSING THE EXAM AFTER RETAKES LEADS TO OBTAINING A CERTIFICATION THAT ENHANCES EMPLOYMENT OPPORTUNITIES.
- **PROFESSIONAL GROWTH:** THE PREPARATION PROCESS OFTEN DEEPENS UNDERSTANDING OF CHILD DEVELOPMENT, BENEFITING CLASSROOM PRACTICE.

CONS

- **COST AND TIME:** MULTIPLE EXAM ATTEMPTS INCREASE FINANCIAL INVESTMENT AND DELAY CREDENTIALING.
- **POTENTIAL DISCOURAGEMENT:** REPEATED FAILURES MAY AFFECT CONFIDENCE AND MOTIVATION.

UNDERSTANDING THESE FACTORS CAN HELP CANDIDATES MAKE INFORMED DECISIONS ABOUT WHEN AND HOW TO RETAKE THE EXAM.

ADDITIONAL CONSIDERATIONS: RENEWAL AND CONTINUING EDUCATION

IT IS IMPORTANT TO NOTE THAT THE CDA CREDENTIAL MUST BE RENEWED EVERY THREE YEARS. RENEWAL REQUIRES COMPLETING CONTINUING EDUCATION AND PROFESSIONAL DEVELOPMENT HOURS, BUT DOES NOT INVOLVE RETAKING THE INITIAL CERTIFICATION EXAM. HOWEVER, IF A CREDENTIAL LAPSES AND A CANDIDATE WISHES TO RECERTIFY AFTER AN EXTENDED PERIOD, THEY MAY NEED TO RETAKE THE EXAM AS PART OF THE REINSTATEMENT PROCESS.

THIS DISTINCTION UNDERSCORES THAT RETAKING THE CDA EXAM PRIMARILY APPLIES TO INITIAL CERTIFICATION RATHER THAN ROUTINE RENEWAL.

FINAL THOUGHTS ON RETAKING THE CDA EXAM

THE POSSIBILITY TO RETAKE THE CDA EXAM PROVIDES A VITAL SAFETY NET FOR CANDIDATES COMMITTED TO EARNING THIS RESPECTED CREDENTIAL. WHILE THE EXAM PRESENTS CHALLENGES, THE STRUCTURED RETAKE POLICIES ENCOURAGE DELIBERATE PREPARATION AND CONTINUOUS LEARNING. CANDIDATES WHO APPROACH RETAKES STRATEGICALLY—LEVERAGING RESOURCES, ANALYZING WEAKNESSES, AND MANAGING TEST STRESS—SIGNIFICANTLY ENHANCE THEIR PROSPECTS OF SUCCESS.

Saran Stewart, 2020-02-01 As academics in postcolonial Caribbean countries, we have been trained to believe that research should be objective: a measurable benefit to the public good and quantifiable in nature so as to generalize findings to develop knowledge societies for economic growth. What happens, however when the very word “research” connotes a derogatory term or semblance of distrust? Smith (1999) speaks towards the distrustful nature of the term as a legacy of European imperialism and colonialism. Against this backdrop, how do Caribbean researchers leverage recognized and valued (indigenous) methods of knowing and understanding for and by the Caribbean populace? How do we learn from indigenous research methods such as Kaupapa Maori (Smith, 1999) and develop an understanding of research that is emancipatory in nature?

Decolonizing qualitative methods are rooted in critical theory and grounded in social justice, resistance, change and emancipatory research for and by the Other (Said, 1978). Rodney's (1969) legacy of “groundings” provides a Caribbean oriented ethnographic approach to collecting data about people and culture. It is an anti-imperialist method of data collection focused on the socioeconomic and political environment within the (post) colonial context. Similar to Rodney, other critical Caribbean scholars have moved the research discourse to center on the notions of resistance, struggle (Chevannes, 1995; Feraria, 2009) and decolonizing methodologies. This proposed edited volume will provide a collective body of scholarship for innovative uses of decolonizing qualitative research. In order to theorize and conduct decolonizing research, one can argue that the researcher as self and as the Other needs to be interrogated. Borrowing from an autoethnographic ontology, the researcher or investigator recognizes the self as the unit of measure, and there is a concerted effort to continuously see the self, seeing the self through and as the other (Alexander, 2005; Ellis, 2004). This level of interrogation may require frameworks such as Reasonable Humanism in which there is a clear understanding of the role of the researcher and researched from a physiological and psychosocial standpoint. Thereafter, the researcher is better prepared to enter into a discourse about decolonizing methodologies. The origins of qualitative inquiry in the Caribbean can be traced to political and economic discourses – Marxism, postcolonialism, neocolonialism, capitalism, liberalism, postmodernism- which have challenged ways of knowing and the construction of knowledge. Evans (2009) traced the origins of qualitative inquiry to slave narratives, proprietor's journals, missionaries' reports and travelogues. Common to the Caribbean is an understanding of how colonial legacies of research have ridiculed oral traditions, language, and ways of knowing, often rendering them valueless and inconsequential. This proposed

edited volume acknowledges the significance of decolonizing approaches to qualitative research in the Caribbean and the wider Caribbean diaspora. It includes an audience of scholars, teacher/researchers and students primarily in and across the humanities, social sciences and educational studies. This proposed volume would provide much needed knowledge and best practice strategies to the community of researchers engaged in decolonizing methodologies. Additionally, this volume will allow readers to think of new imaginings of research design that deconstruct power and privilege to benefit knowledge, communities and participants. It will spark key objectives, directions and frameworks for deeper discussions and interrogations of normative, westernized and hegemonic approaches to qualitative research.
