BOTH SERVE AS SECURITY INSTRUMENTS, GIVING THE LENDER THE RIGHT TO FORECLOSE ON THE PROPERTY IF THE BORROWER DEFAULTS. THE DEED OF TRUST INVOLVES A THIRD-PARTY TRUSTEE, WHEREAS A MORTGAGE IS A DIRECT AGREEMENT BETWEEN THE BORROWER AND LENDER.

3. CLOSING DISCLOSURE

5. AFFIDAVITS AND DECLARATIONS

VARIOUS AFFIDAVITS MIGHT BE INCLUDED TO CONFIRM THE BORROWER'S IDENTITY, OCCUPANCY INTENTIONS, AND OTHER LEGAL DECLARATIONS. THESE HELP PREVENT FRAUD AND ENSURE COMPLIANCE WITH LENDING REGULATIONS.

TIPS FOR USING YOUR LOAN SIGNING DOCUMENTS CHEAT SHEET EFFECTIVELY

CLOSING DISCLOSURE (CD)
