WHEN IS THE PASS LIST RELEASED?

THE TIMING VARIES SLIGHTLY DEPENDING ON THE EXAM SESSION, BUT GENERALLY:

- **FEBRUARY EXAM:** RESULTS AND PASS LISTS ARE RELEASED IN LATE APRIL OR EARLY MAY.

ONCE CLEARED THROUGH CHARACTER AND FITNESS, SUCCESSFUL CANDIDATES ARE INVITED TO PARTICIPATE IN AN ADMISSION CEREMONY, WHERE THEY TAKE THE OATH OF OFFICE AND OFFICIALLY BECOME MEMBERS OF THE MASSACHUSETTS BAR.
